7. Information on authorship of scientific papers and thesis chapters: Authorship

8. Information on duration and contents of teaching by PhD candidates: <u>Teaching time</u> <u>PhD candidates</u>

9. All supervisors of PhD candidates working at VU Amsterdam are obliged to follow the basic training course Supervising PhD candidates (starting or senior version) (offered by HRM). This also applies to experienced supervisors, unless they receive permission from the head of the department to follow a customised trajectory.

There are more (in-depth) training courses aimed at supervising PhD candidates from the VU Center for Teaching and Learning (CTL).
